- EU Zone 28 member countries, 0.5 billion citizens producing \$18 trillion every year


Timeframe:

• 28 May 2018

Details:

- Mandatory breach notifications fast turnaround and large fines (2%-4%)
- The 'Right To Be Forgotten' Article 17 IT ability to be found
- Consumer Profiling Restricted Data should not be used without consent
- Be Accountable for your Data Data Protection Officer (DPO) > 250

Use Cases for Classification

- I want to classify my information to
 - make better information retention decisions
 - make better eDiscovery decisions or investigations
 - include items for **supervisory review**
 - classify personally identifiable information (PII) and make better information protection decisions
 - enable risk analysis and conduct any necessary remediation
 - be compliant with industry regulations and avoid fines
- I want to **reclassify** for all the above reasons
- I want to reclassify when changing my policies

Information Classifier Risk and Compliance Analyzer

WHAT

- Embedded tool within VIC for policy validation
- Test an entire folder against specific policies

WHY


- Verify new custom policies
- Test larger amounts of data against one or more policies to gain confidence in policies
